Description of necessary first aid measures

Eye contact

Precautions for safe handling

Protective measures

SECTION 8: Exposure controls/personal protection

Individual protection measures

Hygiene measures

Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. Most gloves provide only a short time of protection before they must be discarded and replaced. Body protection
