### Personal precautions, protective equipment and emergency procedures

#### **For non-emergency personnel**

### Methods and materials for containment and cleaning up

#### **Small spill**

#### **Large spill**

Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. If emergency personnel are unavailable, contain spilled material. Suction or scoop the spill into appropriate disposal or recycling vessels, then cover spill area with oil absorbent. ##### Hand protection
