Methods and materials for containment and cleaning up

Advice on general occupational hygiene

Section 8. Exposure controls/personal protection

Body protection

Use of protective clothing is good industrial practice. Cotton or polyester/cotton overalls will only provide protection against light superficial contamination that will not soak through to the skin. Overalls should be laundered on a regular basis.
