## Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

#### For non-emergency personnel

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. ### Precautions for safe handling

#### Protective measures

## Section 8. Exposure controls/personal protection

### Appropriate engineering controls
