Section 3: Hazard Identification

Emergency overview: A transparent liquid with slight ammonia odor. May cause moderate eye irritation, dizziness nausea, gastrointestinal tract irritation, and nervous system effects.

Routes of Entry: Contact with eyes and skin, ingestion and inhalation

Physical state: Liquid

Color: Transparent

Odor: Slight ammonia

Potential health effects

Eyes: may cause slight to moderate eye irritation

Skin: May cause slight to moderate irritation. May be harmful if absorbed through the skin

Section 4: First Aid Measures

Eye contact: Hold eyelids and flush with a steady, gentle stream of water for at least 15 minutes. Seek immediate medical attention, preferably with an ophthalmologist. If physician is not immediately available, eye irrigation should be continued for an additional 15 minutes.

Skin: Immediately wipe off excess material off skin with dry cloth then wash with plenty of soap and water for at least 15 minutes. Seek medical attention if irritation develops or persists. Remove contaminated clothing and shoes and clean thoroughly before re-use.

Inhalation: Remove from immediate source of exposure and assure that victim is breathing. If not breathing, administer cardio-pulmonary resuscitation (CPR). If breathing is difficult, administer oxygen if available. Seek medical attention.

Ingestion: If swallowed, do not induce vomiting. If victim is conscious and alert, give 1-2 glasses of water to drink. Do no give anything by mouth to an unconscious person. Seek medical attention immediately. Do not leave victim unattended. To prevent aspiration of swallowed product, lay victim onside with head lower than waist. Vomiting may occur spontaneously. If vomiting occurs and the victim is conscious, give water to further dilute the chemical.

Medical conditions possibly aggravated by exposure: Inhalation of product may aggravate existing chromic respiratory problems such as asthma, emphysema or bronchitis. Skin contact may aggravate existing skin diseases.

Unusual Fire and Explosion Hazards: Vapors can travel along surfaces to distant ignition sources and flash back. Vapors can spread along ground and collect in low confine areas. As with any organic material, contact with strong oxidizers may cause fire or explosion.

Section 6: Accidental Release Measures

Personal precautions: Wear chemical goggles, body-covering protective clothing, chemical resistant gloves, and rubber boots. Use NIOSH approved respirator where mist occurs.

Spills: Ventilate area. Remove sources of ignition. Isolate hazard area. Absorb spill with inert material (e.g. vermiculite, sand, earth or non-combustible absorbent material) and place in chemical waste container. Rinse the spill area with water. Prevent entry into sewers and waterways.

Handling: Keep away from heat, sparks, and flames. Keep container tightly closed when not in use. Avoid contact with skin, eyes and on clothing. Avoid breathing vapor or mist. Remove contaminated clothing and wash thoroughly after handling. Promptly clean residue from closures with cloth dampened with water. Promptly clean up spills.

Storage: Keep away from sources of ignition. Store in an area that is cool, dry and well ventilated. Store in clean plastic containers. Residual vapors might explode on ignition; do not apply heat, cut, drill, and grind or weld on or near this container.
