The substances prohibited in accordance with directives are:

- Cadmium (Cd): < 100 ppm
- Lead (Pb): < 1000 ppm
- Mercury (Hg): < 1000 ppm
- Hexavalent Chromium: (Cr VI) < 1000 ppm
- Polybrominated Biphenyls (PBB): < 1000 ppm
- Polybrominated Diphenyl Ethers (PBDE): < 1000 ppm
- Bis(2-Ethylhexyl) phthalate (DEHP): < 1000 ppm
- Benzyl butyl phthalate (BBP): < 1000 ppm
- Dibutyl phthalate (DBP): < 1000 ppm
- Di isobutyl phthalate (DIBP): < 1000 ppm

None of the listed substances are present in Vacseal products at or above the specified concentrations 0.1% (by weight) for, lead, mercury, hexavalent chromium, PBB, PBDE, DEPH, BBP, DPB or DIBP and 0.01% (by weight) for cadmium. Vacseal products, commercially available on the date of this letter, include VACSEAL® liquid formula, VACSEAL® Aerosol formula, and VACSEAL® II liquid formula.
